Course Code	Course Name	Course Outcome
PLSGCC01	Introduction to Political Theory	This course is divided into two sections. Section A introduces the students to the idea of political theory, its history and approaches, and an assessment of its critical and contemporary trends. Section B is designed to reconcile political theory and practice through reflections on the ideas and practices related to democracy.
PLSGCC02	Indian Government and Politics	This course acquaints students with the constitutional design of state structures and institutions, and their actual working overtime. Student can learn the Indian Constitution accommodates conflicting impulses (of liberty and justice, territorial decentralization and a strong union, for instance) within itself. The course traces the embodiment of some of these conflicts in constitutional provisions, and shows how these have played out in political practice.
PLSGCC03	Comparative Government and Politics	In this course, students will be trained in the application of comparative methods to the study of politics. The course is comparative in both what we study and how we study. In the process, the course aims to introduce undergraduate students to some of the range of issues, literature, and methods that cover comparative political.
PLSGCC04	Introduction to International Relations	This course introduces the causes of international conflict and cooperation. Topics include war initiation, crisis bargaining, international terrorism, nuclear strategy, interstate economic relations, economic growth, international law, human rights, and environmental politics
PLSGDSE01A	Themes in Comparative Political Theory	The present study covers the various themes in the Contemporary Political Theory. Issues such as citizenship, rights, inequality, liberty, democracy, state, swaraj, social justice, patriarchy emerging from the writings of thinkers as diverse as Aristotle to Nehru and Narayan form the crux of the present study.
PLSGDSE01B	Administration and Public Policy: Concepts and Theories	The paper seeks to introduce the interface between public policy and administration in India. The essence of public policy lies in its effectiveness in translating the governing philosophy into programs and policies and making it a part of the community living. It deals with issues of decentralization, financial management, citizens and social welfare from a non-western perspective.
PLSGSEC01	Legislative Support	This course will enhance the knowledge of the students on the legislative process of the country. The purpose of the course is also to enhance the skills of the students and to broaden their understanding of the different tiers of governance in India.
PLSGSEC02	Public Opinion and Survey Research	This course will introduce the students to the debates, principles and practices of public opinion polling in the context of democracies, with special reference to India. It will familiarize the students with how to conceptualize and measure public opinion using quantitative methods, with particular attention being paid to developing basic skills pertaining to the collection, analysis and

PLSGSEC03	Democratic Awareness with Legal Literacy	The student should be aware of the institutions that comprise the legal system - the courts, police, jails and the system of criminal justice administration. Have a brief knowledge of the Constitution and laws of India, an understanding of the formal and alternate dispute redressal mechanisms that exist in India, public interest litigation. Have some working knowledge of how to affirm one's rights and be aware of one's duties within the legal framework; and the opportunities and challenges posed by the legal system for different sections of persons.
PLSGSEC04	Conflict and Peace Building	The course encourages the use of new information technologies and innovative ways of understanding these issues by teaching students skills of managing and resolving conflicts and building peace through techniques such as role-play, simulations, street theatre, cinema and music on the one hand and by undertaking field visits, interacting with different segments of the civil society including those affected by conflicts as well as diplomats, journalists and experts, on the other.
PLSGGE01	Reading Gandhi	it will interest anyone who wants a deeper understanding of the Mahatma's writings. This course covers all of Gandhi's major thoughts-from Satyagraha and Swaraj to his understanding of untouchability, the environment and issues related to women. Additionally, the course comprehensively analyzes commentaries on Gandhi by eminent scholars from various fields, such as Terence Ball and Quentin Skinner. Written in a vivid yet accessible manner with plenty of examples, photographs and diagrams, this course will bring Gandhi's writings alive for the student.
PLSGGE02	Nationalism in India	The purpose of this course is to help the students understand India's colonial past, the shaping of the nationalist ideology and the unfolding of the national movement. Integral to the course is the understanding that ideas of democracy and freedom and corresponding social relations and political and institutional practices took shape in the context of the anti-colonial struggles.
