Theme of the Webinar

The outbreak of the Covid-19 pandemic has had a huge impact on the political, economic, religious and financial structure of not only India but also the whole world. During national lockdown in India, it was hazardous for the migrant labourer and even more arduous for women migrant workers. They came across many livelihood challenges like unemployment, lack of nutrition, government support, societal security, health facility, etc. which were repeatedly underlined in numerous mass Media. COVID-19 pandemic has emerged as a crisis that has impacted all spheres of human life. The pandemic has disproportionately impacted the world's poor population in terms of livelihood and survival. India witnessed a massive crisis among migrant workers. In this context, this webinar proposes to explore the impact of COVID-19 pandemic on women migrant workers and their families in India. In this context, the most pertinent question is: what would be new Challenges and Opportunities? Will the arena of challenges in implementation/analyzing grassroots impact of law and policy measure in Covid-19 pandemic, Post-Covid-19 period be marked by more conflict or will there be a coordinated approach to address the rising challenges regionally? The one-day international webinar aims to address these issues with a focus on world and also special focus on India.
